Sub:- General Diary against some hooligans gathered in front of my school (Siliguri Netaji High School, Subhashpally, Siliguri) and in front of my house (42, J.C Bose Road, Ward No.-17, Hakimpara, Khelaghar More, Siliguri-734001) for the purpose of extorting money by force through fear from me on 19.11.2024 (Tuesday).

Sir,

With due respect, this is to inform you that my father Sri Indra Mohan Ghosh (Age-78 years), S/O- Late Narayan Chandra Ghosh recently (in the month of October 2024) sold his house which was located in Jalpaiguri (North Senpara, P.O & Dist.- Jalpaiguri, Pin-735101). After that some hooligans/antisocial elements along with some land brokers of that area (North Senpara, P.O & Dist.- Jalpaiguri, Pin-735101) are continuously giving threatening to us (me, & my father) over mobile phones from different numbers for a huge amount of money till date. They also threatened my mother-in-law (Mrs Krishna Sarkar, 74 years), in my absence with same intensions at my home. For your kind information they gathered in front of my school (Siliguri Netaji High School, Subhashpally, Siliguri) & in front of my house (42, J.C Bose Road, Ward No.-17, Hakimpara, Khelaghar More, Siliguri-734001) for the purpose of extorting money by force through fear from me and my father on 19.11.2024 (Tuesday) at around 12.41pm (Necessary CCTV footage is attached with this letter). This is for your further information that all the miscreants drove in with a vehicle bearing No. WB74BF-6156. In this situation all of us (me, my father & my mother-in-law) are in a state of extreme fear and mental trauma.

I'd be thankful to you, if you'd kindly take appropriate and necessary steps against the above-mentioned matter with utmost importance at the earliest and help us to get rid of such mental trauma and anxiety.
