Subject : F.I.R

Sir,

In producing herewith one arrested accused namely Manjay Barman (23 yrs approx), S/O- Lt. Bhaben Barman of Sishabari Bazar, Purbo Rangia, PS- Matigara, Dist- Darjeeling along with seized vehicle bearing Reg. No. WB 73 G 5074 loaded with riverbed materials, I PSI Avijit Banik of Matigara P.S. SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 24.11.2024 at 04:30 hrs during my special mobile van duty, received an information from reliable source that one Tractor loaded with illegally mining riverbed materials is coming from Tarabari Ghat side. On receiving the information I along with available force rushed to the spot to work out the information. Under information and kind order of I/C Matigara P.S on arrival at Haler Matha, Shivmandir under Matigara P.S area, I found said Tractor bearing Reg. No. WB 73 G 5074 loaded with riverbed materials going towards Shivmandir. Subsequently, I asked the driver of the vehicle to stop but he rushed from the spot to avoid police arrest. However I managed to stop the vehicle at SP Mukherjee Road and asked the driver to produce valid documents / papers of the said riverbed materials, but he failed to produce any valid documents in support of said materials. As such I also seized the above noted loaded Tractor under proper seizure list and arrested the driver namely Manjay Barman (23 yrs approx), S/O- Lt. Bhaben Barman of Sishabari Bazar, Purbo Rangia, PS- Matigara, Dist- Darjeeling under proper memo of arrest and brought to the above noted vehicle at P.S. The whole process of seizure and arrest was made in between 05:05 hrs to 05:15 hrs. The whole process of seizure was made under videography.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Manjay Barman (23 yrs approx), S/O- Lt. Bhaben Barman of Sishabari Bazar, Purbo Rangia, PS- Matigara, Dist- Darjeeling and the seized vehicle bearing Reg. No. WB 73 G 5074 under proper section of law and arrange for its investigation.
