I, Sri Bikash Agawad, son of Late Murad  
Sukanta Saha, resident of Sukanta Saha, Nilbarpally, Siliguri  
do hereby lodge this Complaint against one Akshay  
More, owner of Laptop & Mobile repairing shop  
namely Dr. Display situated at Panitanki More,  
Siliguri to the effect that I have given my  
Macbook pro 1206 whose screen was broken for  
repair to Mr. Akshay More on 06.11.2024.  
It was agreed that Mr. Akshay More shall  
replace the screen of my Macbook pro with the  
Original screen of Macbook pro and for that he  
charged Rs. 21,000/- from me. I agreed to pay

He said since the original price of Original Screen of Macbook pro is more or less the same.

Today i.e. 24.11.2024, at around 11:00 am I went to his shop Dr. Display to collect my Macbook where I found that the Screen replaced by his was of inferior duplicate quality and due to fixing of duplicate Screen the keyboard has also got damaged and my laptop was not working. Since it is a Apple Macbook which costs around Rs. 1.50 lakhs and any use of duplicate Spareparts gets damage the other Spare parts also. On questioning regarding the use of duplicate display Screen and damage of keyboard the said Ashay alone became furious and started abusing me with filthy languages and threatened to kill me inside his shop. I being afraid of such monster behaviour I called my brother-in-law Anup Jindal and he reached at the shop and very quietly questioned regarding the use of duplicate product and asked to rectify the same but the said person started abusing my brother-in-law with filthy languages and he got hold of collar of my brother-in-law and hit him with fists and blows and the same is also captured in the CCTV Camera installed in his shop. He further threatened me, my brother-in-law and our family that he is a very reputed Don of the locality and


he will even not hesitate to get us murder by  
hiring and paying ransom to Gundas.

The said Ashay Bose, owner of Dr. Display  
who is dealing with spare parts of Smartphone and  
Laptop of iPhone, iPad and Macbooks is selling  
~~the~~ and installing the duplicate and Counterfeit  
Products in the name of Original products.

The said person is cheating public at large  
by selling Counterfeit products in the name of  
original products. The said person has displayed  
Original box of iPhone and Apple products but  
is selling duplicate product inside them and  
has committed forgery and on being caught he  
became furious and manhandled us inside his  
shop.

The said person is cheating public at large by  
taking money of original spare parts and then  
installing duplicate spare part and damaging the  
product of the Customer. The same can also be verified  
by seizing the boxes of original Apple spare part from his shop.  
I humbly request you to book this person  
under relevant provisions of law and take  
necessary steps for offences committed by him.
