beg to state as follows:

That my son namely Md. Nausad Khan  
was married to one Muskan  
Khatun S/o Md. Muzaffar resident  
of Tetultala, Majinda, W/O,  
Ward No. 4, Siliguri, Dist.: Dajeling.  
Since the day of marriage, there  
was always dispute between my  
son and daughter-in-law. She  
would pick up quarrels without  
any reason and would not do  
a single household work. Every  
now and then she would keep on  
demanding huge amount of money  
from my son for doing party.

② That out of the medicals they have a 7 month old daughter who was admitted in civil hospital due to cough and cold. After discharging her daughter she came back home and started fighting with my wife namely Gulshan Khatoon and slapped her by pulling her hair lock. When she raved, hives and cries my said daughter in law ran away from there and went to her paternal house.

③ That today i.e. 24.11.2024 the father of my daughter in-law namely Md. Muzaffar called a meeting to solve the issue. At around 4:00 pm the said Khushboo Khatoon, Md. Muzaffar, Md. Mursif, Md. Tehsin, Md. Hasbul who are all the relatives of my said daughter in law along with 200 more men and women forcefully entered my house.

⑧ That- He said Md. Musaffar and Md. Kasbut pulled my wife by her hair locks and dragged her out of the house towards the main road and threw her on the road where on Md. Kasbut tore open the clothes of my wife exposing her body parts and started abusing her filthy languages.

⑨ That my daughter-in-law Khuseba Khatun along with her relatives pulled the duppatta of my wife with the intention of strangulation and killing her on ~~respective spot~~.

That- all the above had entered my house with the intention of killing my wife and forcing my son to live with her alone. The above named are dangerous people and are continuously threatening to kill my wife and son. kindly take instant action.
