1. 12 (Twelve) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A.

I am submitting a written complaint against the above noted accused person to the effect that on 18.11.24 night at 22-35 hrs received source information that one person was selling Liquor illegally at Fulbari bypass More near Maharaja Agrasen Hospital under PS- New Jalpaiguri, Dist .-Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to you and duty officer of NJP PS and as per your instruction myself along with , ASI Monaj Majumder C/1462 Sajan Tamang, VP- 13 Jamirul Islam CV/306 Biswajit Roy all of NJP PS, SPC left for Fulbari bypass More to verify the veracity of information vide NJP PS GDE No. 1033 Dated- 18.11.24. On arrival at the spot at 22-55 hrs it was found that one person mentioned above was selling liquor illegally from his open temporary shop to his designated customers to earn huge money for his livelihood .
