Sir,

I, SI Ganesh Roy of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Arjun Das (38) S/o Nanda Das of Paschim Dhantala PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest along with following seized articles;

1. 12 (Twelve) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A.

I am submitting a written complaint against the above noted accused person to the effect that on 18.11.24 night at 22-35 hrs received source information that one person was selling Liquor illegally at Fulbari bypass More near Maharaja Agrasen Hospital under PS- New Jalpaiguri, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to you and duty officer of NJP PS and as per your instruction myself along with, ASI Monaj Majumder C/1462 Sajam Tamang, VP- 13 Jamirul Islam CV/306 Biswajit Roy all of NJP PS, SPC left for Fulbari bypass More to verify the veracity of information vide NJP PS GDE No. 1033 Dated- 18.11.24. On arrival at the spot at 22-55 hrs it was found that one person mentioned above was selling liquor illegally from his open temporary shop to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession and seized the same as per proper seizure List and labeled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 23-05 hrs to 23-30 (seizure Total approx 7.2 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Arjun Das (38) S/o Nanda Das of Paschim Dhantala PS- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
