Sir,

I Sri Sayan Sadhukhan , Station Manager, NJP gate bazaar CCC, WBSEDCL, hereby lodge a report against Mostaque Alam son of Mokijuddin Alam at Mamatapara, PS-New Jalpaiguri, Dist: Jalpaiguri , for unauthorizedly extending power to deemed disconnected premises from his service connection having meter number L1011131 iro consumer id -400017026 as liable u/s 135/1(e) of electricity act 2003 & Amendment act 2007.

On dated 21.11.2024 at about 01.17 pm , I along with 1) Bijay Lakra, DE(E), S & LP, 2) Sri Bhaben Roy, SO,S & LP both are from Darjeeling Region Office, WBSEDCL, and other officials of WBSEDCL visited the premises of said above for inspection. During inspection it was found that unauthorized extending of power to deemed disconnected premises, as liable u/s 135/1 (e) & of electricity act 2003 & Amendment act 2007.

In this regard it may be noted the accused consumer was extending power unauthorizedly to the nearby deemed disconnected premise which was having a disconnected meter with meter serial number T1486639, disconnected on 26.02.2015 due to non-payment of OSD of Rs.5,008.17/-

As the dishonest use of electricity is detected, the service connection has been disconnected and Meter vide Meter No – L1011131 has been dismantled with PP Box & other details separate sheet are enclosed herewith. The above articles have been seized by me by preparing a formal seizure list duly signed by the accused consumer.

Mostaque Alam son of Mokijuddin Alam at Mamatapara, PS-New Jalpaiguri, Dist: Jalpaiguri has committed an offence u/s 135/1(e) of Electricity act 2003. You are requested to take cognizance of the same by treating this complaint as an F.I.R.


