near Kadam Bagan, am submitting this
application to report a grave incident
involving physical assault, robbery and
threats against my family by a group
of 8-9 individuals, mansul and sehasan
in my home.

The incident occurred on 20-11-2024 and
despite the severe nature of the attack,
my family and I are deeply concerned
about the lack of safety in our area
due to this accident. and the same
individuals who are also involved in
illegal gambling activities near our
home.

Key Details of the incident:

1.) Attack and Assault :- My second
son, Saurabh Lal was returning home

home from work at 8:30 pm (around)
when he was assaulted for requesting
them to move their vehicle (far wheel)
which was on the way.

2) Injury and threats:- By listening the
sound my younger son Udeep Lal
came on the out side of home tried
to intervene but was brutally beaten
on my both son. resulting in severe
injuries, including nose bleeding
from Udeep's nose. My wife and I
also come outside of house by listening
too loud sound and became victims
of their aggression when we come
out. They disgracefully raised their
hand on my wife and also on me
My wife's nose and ear jewelry were
snatched, causing further trauma.

3) Threats to life and property: They
threatened to throw us out of our
house and harm my sons and family
if found alone, and how gents
can raise their hand on woman.
