Torture, exploitation in treatment centre

Sir,

I am Saptanshi Das, 23 y/o from Dabgram Siliguri, admitted to a rehab centre in ~~PO~~ 20th August, 2024 (called 'New Rebam - Foundation' in Milanmore, Champasari, Siliguri). The staffs who came to pickup started beating & assaulting as soon the vehicle crossed our locality and I was literally kidnaped from my home as pickup. Soon after reaching the centre I was beaten ~~and~~ badly with belts, steel pipe and I was slapped many times which gave me an eye injury. I was forced to spit on floor and lick.

The staffs are Animesh, Koushik, Kabir, Shantone, Sovam, and others under the Authority of Nilay Saha, who runs the centre. There is no doctor in the centre and I was not given any treatment nor any medicine for the eye injury I got from the beatings. The centre has no medical facilities and run by drug-addicts who torture the patients very badly by tying, beatings, making standing for hours and whole night without water and bathroom. They Authority manipulated my mother by lying about treatment and proper facilities provided there and also lied whenever my mother reached there to meet me they didn't allow to meet and lied about treatment and food provided there. My mother was asked by the authority to bring things like bedsheet, towel, soap, cloths, tooth paste, brush and many other things which was neither given to me, nor informed to me and many things were missing from the bag when I was discharged in 16th September 2024. Strict action must be taken against the Authority and staffs who torture the patients and make money from our family.
