I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Lakshman sioneral andra Das (User), S/O- Late Shachin Das, Inspection Spot: Fakdaihari (Padha Cobinda Paras) Shipuri Polica Chandra Das (User), S/O- Late Shachin Das, Inspection Spot: Fakdaibari (Radha Gobinda Bazar), Silouri Ghogomali, PS-Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Residential Address: Niranjan Nagar, Hathat Colony, Ward- 36, SMC, P.O. -Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006) (Consumer ID: 401182595), has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose as stated here under.

On 25.11.2024 at about 18:15 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Arnab Ray, J.E. (E) (Grade-II), 2. Mr. Anup Lama, Sr. OE & 3. Mr. Mangru Baraik, Sr.TSH, all are attached with Subhaspally CCC, WBSEDCL, entered into the Commercial premises of Mr. (late) Shachin Das situated at Fakdaibari (Radha Gobinda Bazar), P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 401182595), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection, the aforesaid accused, Mr. Lakshman Chandra Das (User), S/O- Late Shachin Das, Inspection Spot: Fakdaibari (Radha Gobinda Bazar), P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Residential Address: Niranjan Nagar, Hathat Colony, Ward- 36, SMC, P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006) (Consumer ID: 401182595), was found consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 401182595 & Meter No.: B2835452 which was disconnected on 02.09.2021 due to having outstanding dues of electricity of Rs.6,553.00 by that time (excluding LPSC). Moreover, the last meter consumption up to which billing was raised is 3327 kWh. And, during inspection on 25.11.2024, the service connection was found 'Physically Live' as well as the aforesaid accused person was found consuming electricity through that meter installed in that earmarked Commercial premises for Commercial purposes & the aforesaid energy meter was found 'performing normal' having last reading of 5587 kWh during seizure of the meter. Thus the service connection was used in unauthorized manner & no further billing could have been possible, because of which WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected his Service Connection and seized one number single phase Energy Meter with P.P. Box having device SI No.: B2835452, make: Bentec, Rating: 240V, 5-30A, 50Hz, 3200 imp/kWh (L.R.: 5587 kWh) connected with some portion of Incoming & Outgoing wires which have been used for Unauthorized Reconnection of the 'Deemed Disconnected' service connection (Consumer ID: 401182595) & consuming electricity dishonestly in unauthorized manner in the aforementioned Commercial premises for the Commercial purposes under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & Witnesses & Representative (i.e. Son) of the Accused Person & other local witnesses. The inspection team members left the aforesaid premises at 19:00 hours on the same day after observing all formalities.

So the accused person Mr. Lakshman Chandra Das (User), S/O- Late Shachin Das, Inspection Spot: Fakdaibari (Radha Gobinda Bazar), P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Residential Address: Niranjan Nagar, Hathat Colony, Ward- 36, SMC, P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006) (Consumer ID: 401182595), has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
