Sir,

In producing herewith one accused person namely Bijay Ray-35 yrs s/o Lt Hira Ray of Prakashnagar, ward No-43, PS- Bhaktinagar Dist Jalpaiguri with one white colour Pickup vehicle loaded with River Bed materials/Sands having Registration No- WB73E/7582 under seizure in c/w above noted case.

I beg to report that, I SI Youel Lepcha S/O Jai Tshering Lepcha of Bhaktinagar Police station under Siliguri Police Commissionerate lodge a written complaint against the above noted person (Driver) with the above noted vehicle to the effect that today i.e. 25.11.24 at 21.35 hrs as per source information I along with SI Srimanta Chatterjee, SI Rantu Halder, ASI Dipak Karmakar, C/374 Debraj Biswas all of Bhaktinagar PS had been to Sevoke road, near Don Bosco more under Bhaktinagar PS vide Bhaktinagar PS GDE No-1360 dated 25.11.24 and found above noted vehicle loaded with illegal sands was going towards Salugara through sevoke road under Bhaktinagar PS. On chasing we apprehended the above noted person with vehicle. On checking the vehicle and found loaded with sand. Further, hence there was reason to believe that the driver of above noted vehicle had procured the loaded sand illegally and transporting the same for illegal gain from Prakashnagar Mahananda River as he failed to produced any valid documents/Licence in respect of vehicle or sands.

On further grilling they procured the river bed materials, sand illegally from Prakashnagar Mahananda River bed and carrying/transporting the same to Salugara side from river bed for his wrongful gain without any valid document. Under the circumstances, I seized the above noted vehicle along with loaded sand under proper seizure list in presence of local witnesses and arrested the driver of the vehicle. The whole process of search, seizure took place in between 21.55hrs to 22.25 hrs under properly audio & video grappled..

Under the above, I pray before your kind end to start a case against the driver namely 35 yrs s/o Lt Hira Ray of Prakashnagar, ward No-43, PS- Bhaktinagar Dist Jalpaiguri under proper section of law and caused its investigation.
