person namely Gangakumar Thakur s/o Dharmendra Thakur  
followed me and insisted me to sit on his Piaggio.  
and said that he would drop me back home. I  
refused to get into his piaggio, then he parked his piaggio  
and followed me. and wanted to indulge in a  
conversation with me and said that he would love  
to drop me back to my place. on being refused the person  
namely Gangakumar Thakur got very angry and then he  
said he will kill me if I don't sit in his piaggio.  
(blue colour).

He followed me till my place. I was really scared  
by his activities. On reaching my house / residence, he  
tried to touch my hand and then he tried to pull my  
clothes, and took my nighty, maroon, and touch my  
private parts, my bangles broke and pulled my hair and  
tried to do wrong things with me. I should

and my son Ankish Mahato, (15 yrs) came out, where he was also physically assaulted by the said Gargakumari Thakur,

I was naked after my nighty was torn, and then in the hys and cry the sisters of Garga Kumari Thakur, namely Pujan Kumari and one of their sister came and assaulted my son and me with a big stone, kicked both my son and myself, and said that they would kill us. I was embarrassed as I was naked, my mental state is unstable.

My son and myself have sustained severe head injury, cut, cold cut injury all over the body and also have sustained bruises on my thighs and knee.

- Having no other alternative, I am approaching before you to take action against the above named culprits at the earliest
