Respected Sir,

I, " **Gita Sharma**", daughter of Late Yogendra Sharma, wife of Anirban Chakraborty, Hindu by religion, Indian National, aged about 39 years, resident of Sarada Skyrise, Opposite of Pintail Village, Dagapur, Post Office & Police Station- Pradhan Nagar, District- Darjeeling, Pin Code- 734001 would like to inform you that today (26.11.2024) at around 12.00 p.m. my mother-in-law namely Smt. Jharna Chakraborty wife of Late Sri Ashit Chakraborty came to my flat with two men and two women and without any notice and illegally broke the lock with lock cutter of my flat where I was ordered by the Learned Judicial Magistrate 1st Class 1st Court at Siliguri to peacefully stay at the said flat and they were further directed by the Learned Court from communicating with me and from alienating my Stri Dhan properties. My husband (Anirban Chakraborty) and his men and agents were directed to stay away from me. Further my husband (Anirban Chakraborty) was directed to secure a peaceful atmosphere in the share household as such I can live peacefully in the same place.

Moreover, my mother-in-law took away my daughter's play items which she usually play at her leisure time. And all their illegally activities are all recorded in the installed CCTV cameras.

It is, therefore, requested to you kindly take cognizance of the offence committed by my husband and my mother-in-law and their agents. I am passing my days in great fear that when my husband with his agent will come and end my life.
