I am writing to formally lodge a complaint regarding a theft that occurred at our factory in Sevoke Road Siliguri Industrial Estate, Plot no 1 A. We have discovered today morning that one of our workers, Mr. Sanjay Das, has been involved in stealing Copper Cables from the factory premises after shutdown.

On 12th November 2024, at approximately 7:30 PM, Mr. Sanjay Das was caught on our CCTV surveillance system stealing approx. 100 meters of copper welding cable from various machines in the factory. The estimated value of the stolen material is approximately ₹40,000. Our workshop was shut done at 6.30 PM on that day. He has entered the closed premises illegally and conducted the theft. Additionally, Mr. Sanjay Das has been absent from work since 23th Oct 2024.

Considering the nature of the theft and the significant financial loss to our factory, we kindly request that you take immediate action to apprehend Mr. Sanjay Das, who is the prime suspect. We are willing to provide the CCTV footage to support our complaint.

In addition, we are attaching a copy of Mr. Sanjay Das's Aadhaar card, his recent passport size photo and his father's mobile number for further investigation. We hope this information will assist you in locating and apprehending the suspect.

We also request that further investigations be conducted to ensure that no additional thefts have occurred and to prevent such incidents in the future. Our factory's security and operations have been compromised, and we trust that you will prioritize this case.

Thank you for your prompt attention to this matter. We look forward to your swift action in bringing the culprit to justice.
