Sir,  
This is to inform you that I Rohit Sarkar owner of  
the property located at D1322 Uttarayan. My Bungalow  
was almost completed. Due to some personal reasons  
I had to stop the work at my Bungalow. My last visit  
on the property was about 6-7 months back.  
Recently I decided to complete the remaining  
works of my Bungalow. So, I visited my property  
to clean the lawns and bushes yesterday and  
got to know about this incidence of theft at  
my property. My property is completely vandalised  
The ceiling of the ground floor is damaged  
Heinously. The wiring and the wires of the  
entire bungalow is stolen, Bathroom Cruisers,  
Bathroom tap, showers from each bungalow is  
also stolen. Glasses inside the bungalow is  
found damaged and broken. Door lock  
is damaged. Due to this incident that had  
happened I have suffered a huge loss. and I find  
Safety at Uttarayan at a very high risk.

Therefore, I would like to kindly request you  
to do the needful to get my lost goods recovered  
please take steps so that I get Justice for the  
above mentioned incident and most importantly  
please take steps so that Safety is maintained  
in Uttarayan. The incident has been detected on 27/11/24  
at 2:35 pm.
