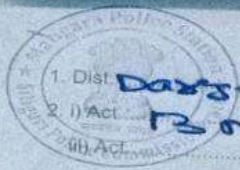

Subject: F.I.R

Sir,

In producing herewith two arrested accused persons namely (i) Mithun Barman S/O Dhaneswar Barman & (ii) Dulal Barman S/O Dhaneswar Barman both of Sishabari, New Rangia, P.S Matigara Dist. Darjeeling along with two seized vehicles having Regn no. WB 74 BQ/ 8387 (Tractor fitted with trolley) & vehicle no. WB- 91/8152 (Tractor with trolley) loaded with river bed materials. I, ASI. Aibul Islam of Matigara P.S do hereby lodge this written complaint to the effect that on 28-29/11/2024 I was deputed to perform morning /night Mobile Patrol duty along with force, since 08:00 hrs to 14:00 hrs (28/11/24) again from 22:00 hrs to 08:00 hrs (29-23/11/24) vide Matigara P.S. C.C. No- 1377, Dated - 28/11/2024, This refers to Matigara P.S. GDE No- 1569 Dated 28/11/2024. On 29.11.2024 at about 04:45 hrs, in course of mobile van duty I received source information that 02 nos. of vehicle loaded with illegal river bed materials are coming from Tarabari Ghat towards Shivmandir. It is to be noted here that an order has already been passed by the District Magistrate, Darjeeling to stop all mining operations on River bed during Monsoon season, vide No. 62/M&M/XIII/DLLRO-DJ/24, Dated 28/06/24. The order is still in force.

On receipt of such information, I informed the matter to I/C of the P.S and I along with force rushed to Sishabari, Halomore and found that vehicle no. WB 74 BQ/ 8387 (Tractor fitted with trolley) & vehicle no. WB- 91/8152 (Tractor fitted with trolley) loaded with river bed materials were coming from Tarabari side. I stopped both the vehicles and asked to the drivers to produce documents in respect of the material which is loaded in their vehicles but they failed to produce any documents in respect of the materials which they were procuring by their vehicles. It is evident that drivers/owners of the vehicles somehow procured the said river bed materials clandestinely, violating Govt. Order, also without paying any revenue to the Govt. Accordingly I seized both the vehicles U/S 105 of BNSS. Subsequently I arrested both the drivers of the vehicles namely (i) Mitun Barman S/O Dhaneswar Barman & (ii) Dulal Barman S/O Dhaneswar Barman both of Sishabari, New Rangia, P.S Matigara Dist. Darjeeling under proper Memo of Arrest.

The seizure was made in between 05:15 hrs to 05:35 hrs on 29.11.2024 total process of seizure was captured in videography through Mobile Phone. I brought both the above noted vehicles at P.S and kept the same at P.S compound.

I, therefore pray before you that a specific case under proper section of Law may kindly be started against the drivers / owners of the seized vehicles namely (i) Mithun Barman S/O Dhaneswar Barman & (ii) Dulal Barman S/O Dhaneswar Barman both of Sishabari, New Rangia, P.S Matigara Dist. Darjeeling and arrange for its investigation.
