Sub: First Information Report

Respected Sir,

I the undersigned would like to draw your kind attention towards the fact that on 25.11.2024 at around 11:30 am I along with Mrs. Sandhya Gurung went to meet one Bikash Chhetri, Son of Sri Ganesh Chhetri, Resident of Shivanagar, near Kanchanjangha Gas Godown, Pradhan Nagar, Siliguri, Post office and Police Station: Pradhan Nagar, District: Darjeeling, Pin Code: 734003 at his residence to ask for the money which I gave him during his financial crisis. That the said Bikash Chhetri took loan amounting to Rs. 42,00,000/- Rupees (Forty Two lakh) only from me and Rs.25,00,000/- Rupees (Twenty Five lakh) only from Sandhya Gurung. When we asked him to return our money, the Accused Person namely Bikash Chhetri showered us with abusive languages and even admitted to all his wrong doing. Thereafter we had huge argument related to the money which he took from us and in between the argument he started physically assaulting us by touching our private parts and even threatened us with dire consequences. That the Accused Person after borrowing the money from us use to pay the money in instalments sometimes due to which we never doubted his intentions and fall prey in his hands and now I realised that since the inception he hatched a ugly conspiracy just to debar us and for illegal pecuniary gain. The Accused Person cheated me and defrauded me and misappropriated the money amounting to Rs.42,00,000/- and when asked for the same, he assaulted me and molested me.

It is pertinent to mention here that due to such incident which took place I got traumatized and I could not take appropriate steps at the earliest and thereafter I confined myself and thereafter with the help and strength from my family members I came before your kind office to file this complaint. Under these circumstances I request you to immediately intervene into this matter and thereby initiate appropriate criminal proceeding against this Accused Person and thereby take necessary steps to arrest the Accused Person.
