Respected Sir,

I, Rebika Subba, residing at Middle Palash, Devidanga, P.S. Pradhan Nagar, Siliguri West Bengal, wish to lodge a formal complaint against my husband, Sanjay Subba, for his deceptive behaviour, neglect, and ongoing harassment concerning dowry demands. Below are the details for your kind attention and necessary action:

Deception Regarding Marital Status

My husband concealed critical details about his personal life before our marriage. He never disclosed that he had been married previously and had a son who has since passed away. Neither I nor my family was informed of these facts prior to the marriage. We only came to know of this after the marriage. Despite his deceit, my family and I tried to forgive him and move forward, but his behaviour has worsened significantly over time.

Irresponsible Behaviour Towards Our Children

My husband has shown a complete lack of responsibility towards the well-being of our children. He has taken money meant for their school fees on several occasions but failed to ensure the fees were paid. He also invites unknown male guests to our home under the pretext of business matters, leaving our two young daughters unattended and unsafe. He refuses to take any meaningful responsibility for the children and dismisses them as "temporary" because they are girls, which is deeply hurtful and discriminatory.

Persistent Dowry Harassment and Misuse of Money

My husband frequently demands dowry money from me and my family, claiming it is for the upbringing of our daughters. However, he uses this money for his personal indulgences, including getting drunk and spending it in bars. This misuse of money intended for the welfare of our children has left us financially strained and emotionally distressed.

Mental Harassment and Threats

He has subjected me to continuous mental and emotional harassment, making derogatory comments and tarnishing my dignity. He often threatens me and my family for more money, leaving me in fear for our safety. His threatening remarks include veiled warnings about accidents, which make me apprehensive about my life and the well-being of my daughters.

Unsafe and Irresponsible Behaviour

My husband's approach to business and personal responsibilities lacks any sense of stability or security. His reckless behaviour puts me and my daughters in a vulnerable position, with no regard for our future or safety.

His actions have caused immense emotional pain and a constant state of fear for my daughters and myself. I have endured this behaviour for a long time, but I can no longer tolerate such abuse. I seek to separate from him permanently and live a safe and peaceful life with my children.

I kindly request you to take strict action against my husband to address his dowry harassment and neglectful behaviour, and to ensure our safety. I am prepared to provide additional details or evidence to aid in your investigation.
