Respected Sir,


With due respect, I Shri Adeep Gurung ,S/o. Late Ram Bahadur Gurung resident of Rohini Tea Garden, P.O. & P.S. Kurseong Dist. Darjeeling, ex servicemen by occupation, would beg to state that :-

1. That my daughter named Divaya Gurung aged about 18 years old, who was preparing for NEET and was residing at Hakimpara with her cousin sister for availing the coaching.
2. That since 04.11.2024 morning my daughter went missing from her rented home. She was untraceable on her phone since then her Phone Number is switched off.
3. That I along with my family tried searching for her all around Siliguri but we could not trace her. Then I filed a missing report at Siliguri Police Station.
4. That from her friend circle we came to know that she was talking over phone with a boy named Sumit Kumal, S/o Dol Bahadur, resident of D-66, Sector - 40, Noida, Gautam Buddha Nagar, Uttar Pradesh- 201301 and whenever he visits Siliguri he used to reside at Himal Overseas Society, Gurung Busty, Siliguri.
5. That I contacted the owner of Himal Overseas Society and we got the contact number of said Sumit Kumal but his number was found switched off.
6. That I enquired the owner of the Himal Overseas Society regarding the family of Sumit Kumal and he gave me the contact number of his father and uncle. When I talked over the phone with the father of the said boy Sumit Kumal I got ill respond from him. The father of Sumit Kumal responded us saying he has no knowledge about the whereabouts of his son and have no contact with him .
7. That since the day of my daughter missing the phone number of Sumit Kumal is also not available.
8. That we have already filed a missing report in context to it and I along with my family waited for positive news but we have got no information about my daughter till today
9. That my daughter was a soft spoken innocent girl who has just attained the age of majority. She was dedicated towards her studies and was preparing for NEET exam . She used to call us normally more than 6 times a day.
10. That Sumit Kumal has been talking with her since many months, he has manipulated, threatened and abducted my daughter in connivance with his father

Dol Bahadur and his uncle, they are totally involved in this matter as we have come to know. Sumit Kumal and his family are originally from Nepal. I found it fishy after talking with his father as he restrained to give us the current information about his son.

11. That recently a visa in his name was issued by the Country, Kingdom of Cambodia on 13.10.2024 bearing visa no. 20240983118355.
12. That I along with my wife are hugely suffering after our daughter went missing. Numerous crimes are occurring against women these days in our society and we are worried if some wrong has been done against her. It has been 25<sup>th</sup> days my daughter is missing.
13. Therefore, I request you to initiate legal action against said Sumit Kumal S/o Dol Bahadur, his father Dol Bahadur and his brother, all are resident of D-66, Sector - 40, Noida, Gautam Buddha Nagar, Uttar Pradesh- 201301, for punishing him as per provision of law. And for this kindness, I shall much oblige to you.


