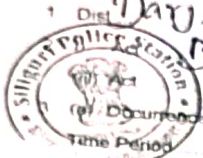

Sub :- Written complaint against Shri Hari Kishan Rampuria S/o Lt. Bhagawan Das Rampuria and Shri Devendra Rampuria S/o Shri Hari Kishan Rampuria, both are resident of Agrasen Road, Khalpara, Siliguri Town, District - Darjeeling, who are tried to kill me on several dates, including today at about 12.30 P. M., with stone with an intention to damage my body as a result of which I have sustained huge injury in my chest, neck, head and other parts of the body.

Respected Sir,

I, Sri Gaurav Rampuria S/o Sri Bishwanath Rampuria, resident of Agrasen Road, Khalpara, Siliguri Town, District - Darjeeling beg to inform you that on 26/11/2024 at about 7.00 P. M said Sri Debendra Rampuria beaten me badly without any reasons in front of my house and I have sustained huge injury in my body and thereafter I went to Siliguri District Hospital for necessary treatment.

That today at about 12.30 P. M. said Sri Hari Kishan Rampuria and Sri Debendra Rampuria again came in front of my house, then I asked them why you have blocked our CC TV camera then said persons used filthy language upon me and my family members as a result of which I have raised my objection and thereafter, said Sri Hari Kishan Rampuria suddenly attacked on me and beaten me badly, he was trying to strangle me, then my father tried his level best to save me from his hands, thereafter said Sri Devendra Rampuria came on the spot and started throwing stone upon me and my father. I have sustained huge injury on my body due to said incident and went to Siliguri District Hospital for necessary treatment. The medical papers dated 26/11/2024 and 28/11/2024 are enclosed herewith for your kind perusal.

That said persons are threatened me and my family members for dire consequences if I lodged any complain against them before the police station and said persons openly threatening me that they will kill me at any opportunate moment and means, therefore I am apprehending that my life is in danger after their threat.
