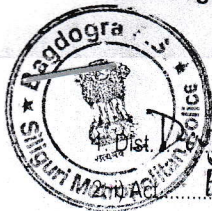

This is to bring to your attention an issue of grave concern regarding illegal water connection, theft/damaging of materials and misuse / wastage of water in different piped water supply scheme. An indicative list is being attached herewith (Annexure-A) though it is not the exhaustive one. It has been noticed that drinking water is being used irresponsibly, causing inconvenience to other households and wasting a vital Govt. resource. Moreover due to this households at the tail end are being deprived of getting benefits of the Jal Jeevan Mission, Project.

Hence, you are requested to take appropriate action to investigate the matter and take necessary steps to for illegal tapping/wasting of drinking water under relevant Law so that smooth water supply of the desired area could be restored.
