(SUB-F.I.R. IN RESPECT OF A MOTOR VEHICLE ACCIDENT)

Respected Sir,

With due respect I would like to inform you that, I, **Tilleshwari Devi**, W/O-**KAPIL DEO PRASAD**, Resident of Bhuttabari, P.O+P.S-Bagdogra, Darjeeling, Pin-734014, hereby inform you that on 25/11/2024 (Monday) at about 09:10 A.M. my husband namely **KAPIL DEO PRASAD**, aged about 69 Years, S/O-Late Suraj Choudhary, R.O-Bhuttabari, P.O+P.S-Bagdogra, Darjeeling, Pin-734014, while going to his residence Bhuttabari from Bagdogra through the left side of the road by riding on a Scooty bearing No-WB-74AH/4797 by wearing helmet at a very moderate speed and when came near to Flyover suddenly one XUV CAR vide no- WB-42AE/1010 which was going to the same direction at a very high and excessive speed and dashed my husband's Scooty from behind in a very rush and negligent manner. As an impact my husband fell down with his Scooty by the side of the road, and sustained severe multiple bleeding injuries all over his body and particularly on head. Immediately he was taken to Paramount Private Hospital, by the help of local people.

The accident occurred due to fault, rash and negligent driving by the part of driver of the XUV CAR vide no- WB-42AE/1010.

Therefore, it's my humble request to you please accept my application as F.I.R. and take strong legal action against the driver of the offending XUV CAR vide no- WB-42AE/1010 and do the needful regarding the above incident as per law.
