with due respect of, Roshni Dhyani, w/o Santosh Kumar, d/o Gopal Dhyani, resident of Mallaguri Suryasen Colony, W-No-1, P.O. Pradheer Nagar P.S. Pradheer Nagar Dist - Darjiling, would like to inform you that my marriage was solemnized on 10.6.2022 as per Special Marriage Act, with Santosh Kumar, s/o Mahendra Thakur, resident of Near Durga Mandir, Kukahi, Haidernagar, P.S. Haidernagar, P.O. Kukahi Dist - Palanur, Thekkilund. After our marriage I went to the house of my husband situated at above mentioned address. That after few days of our marriage my husband and my in laws, Mahendra Thakur (Father-in-law), Manjiri Devi (Mother in law) started abusing me mentally and physically in demand of more dowry. It is pertinent to mention here that at the time of marriage my husband and my in laws took Rs. 3,00,000/- (Rupees Three Lakh only) from my father as dowry. After that they demand of Rs. 5 Lakh, along with one Swift D'zire and Gold ornaments, when I refuse to bring the aforesaid articles, and cash then they became more furious and started more torture and assault upon me. Five months of our marriage we came to Siliguri and lived together at the residence of ward No 45, 15, Beglujatin Colony, near Balaram School, P.S. Paddanwajan Dist. Darjeeling. When we started living at the above mentioned place, my husband returned home in a drunken condition and ~~beat~~ beat me mercilessly whenever I protest the amount of tortured increased. However I fled away from that place in order to save my life.

Sometimes he threatened me and my family with dire consequences. It is also pertinent to mention here that at the time of marriage he also suppressed his identity and introduced himself as an Army officer and showed me an false identity card, so that my family can believe him.

Presently I stay at my parental house and till date he continuously threatened me whenever he met me on road.

Therefore I request you to kindly investigate the matter and take appropriate legal steps against my husband and in laws as per the provisions of law.


