Sir,

In producing herewith three arrested persons namely (1) Prince Jain-28yrs s/o Rajib Jain Daftari of Khalsa Niwas, Near Walis Bakery, PO Champasari, PS Pradhannagar Dist Darjeeling (2) Manish Singha-34yrs s/o Shib Charan Singha of Milan More PS Pradhannagar Dist Darjeeling and (3) Abhijit Majumdar-39yrs s/o Lt Bishnupada Majumdar of Surya Sikha Sarani of Haiderpara PS Bhaktinagar Dist Jalpaiguri under proper arrest u/s 35 of BNSS.

I beg to report that I, ASI Dipak Karmakar s/o Lt Dulal Karmakar now attached at Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested persons to the effect that on 01.12.24 at about 02.45 hrs received an information from Special operation Group, SPC that when they had been to "Tanzanite RCB" Sevoke road to routine visit of closing the Bar in time at 02.00hrs as per order of The Superintendent of Excise, Jalpaiguri vide order no-1669/E Dated 30.11.24 and they are found that the Bar was running in that time after violation of permission by Excise department, Govt of West Bengal, so SOG team requested me to assist them at "Tanzanite Pab & Bar (Level-III)" Sevoke road immediately to control the situation.

After receiving the information as per Kind direction of I/C of PS Myself along with SI Yuel Lepcha, ASI Dhurba Mishra, and force left for "Tanzanite RCB" Sevoke road. After reaching there found that SI Rash Behari Saha, SI Binod Jha and force all are SOG, SPC were present there. As per their statement checked the CC Camera footage found that the allegation is correct. The Bar was running up to 02.45AM after violating the Govt order also misbehave with police team. I tried to serve notice u/s 35(3) BNSS but they refused to accept the notice and showed unwillingness to close the bar. Finding no other alternative, I arrested the above noted persons to enforce the order passed by Govt. authorities after issuing arrest memo.

I therefore pray that a specific case may kindly be initiated against the accused persons viz. (1) Prince Jain-28yrs s/o Rajib Jain Daftari of Khalsa Niwas, Near Walis Bakery, PO Champasari, PS Pradhannagar Dist Darjeeling (2) Manish Singha-34yrs s/o Shib Charan Singha of Milan More PS Pradhannagar Dist Darjeeling and (3) Abhijit Majumdar-39yrs s/o Lt Bishnupada Majumdar of Surya Sikha Sarani of Haiderpara PS Bhaktinagar Dist Jalpaiguri and also management of the Tanzanite RCB under proper sections of law.
