That hearing our hue and cry when our neighbor was gathered they flew away by snatching my 14 gram gold chain which I was wearing. That by the grace of god due to gathering of neighboring people our lives were saved else they have come prepared to kill us.

Under the above circumstances I hereby bring the aforementioned fact to your knowledge and would humbly request you to stop the illegal act and activities by the unknown miscreants.

I sincerely hope that your August Office would consider my present situation in the light of interests of justice, Compassion and urgency and take necessary steps for the safeguard of my life and family as well.

If no penal and appropriate lawful action has been initiated against culprit, the said culprit may follow the same modus operendi to do more offences in future with some other person/s who are vulnerable towards action of Police personnel without having appropriate jurisdiction/authority.
