inher my son namely (1) Md. Arman (18) along with his
relatives & friends namely (2) Md. Rocky Ali (17) s/o Md
Ratik Ali of Ashraf Nagar (Near Isikam Mandir), ward No.
40 SMC, P.S.-Bhakti Nagar, Distt - Jalpaiguri & (3) Md.
Sohail (16) s/o Md. Zafar of Civil Depo, Nepali Buzay
(Back side of Uday Bhawan) Ward No. 7 SMC, P.O. & P.S. Siliguri
Distt - Darjeeling, were at Burdwan Road (In front of Virel
Mega Mart), at that time, the said alleged person namely
