**SUBJECT: F.I.R.**

Sir,

1. That I, Ramanand Pandit, son of Late Shyam Sundar Pandit, resident of Hemanta Basu Colony, ward no-4, wants to inform you about the incident that happened with me at around 6:30 P.M. near Vishal Mega Mart, Siliguri.
2. That my son Gulshan Pandit, resident of Hemanta Basu Colony, ward no-4, is by occupation a Milk Man and delivers milk to his customers every day, and as usual he was going to deliver milk at around 6:15 P.M. and on the way three to four boys were coming from the wrong side and hit my son's bike, and eventually he stopped had a conversation with the boys who had hit my son's bike.
3. That during the conversation those boys in spite of doing the wrong abused my son and took his bike's key and also beat him. They did not stop there and called their family members namely 1. Md. Heera, resident of Koila Deepu, Siliguri, 2. Md. Armaan son of Md. Heera resident of Koila Deepu, Siliguri, 3. Md. Salman son of Md. Heera resident of Koila Deepu, Siliguri, 4. Md. Aman alias Meetu son of Md. Siraj resident of Koila Deepu Siliguri and 4 others.
4. That their family members arrives and started beating my son very badly using equipment like steel chains, and steel bangles. They also took a chair from the nearby store and hit on my son's head, they merely attempt to for a murder.
5. That soon I got the information and I went their with my sons and rescued my son from the attack and took him to the Siliguri District Hospital, as there was severe bleeding from his nose.
6. That my son was married 5 / 12 / 2024, in which my relatives gifted him a golden chain which he was wearing, and after the fight it was found that the chain has also been snatched by them along with cash of Rupees Five Thousand.
7. That when I was coming back from the District Hospital, to lodge a complaint against them, they tried to catch hold of me to beat me, but I however escaped from them and went back home.
8. Sir that this incident has become a serious threat to me and my family's life, and that I request you to take serious action against them as per law, and take necessary steps so that my family feels protected.
