Sir,

In producing herewith 03 (Three) arrested accused persons namely (1) Pradip Das @ Poltu-(M/33 yrs) S/O- Lt. Manik Das of Matangini Colony-II, Tikiapara, W/No- 28, PS- Siliguri, Dist. Darjeeling (2) Bivash Dutta @ Nontai-(M/35yrs) S/O- Lt. Subhas Dutta of Railway Hospital more, Bhuttabari, W/No- 34, PS- NJP, Dist. Jalpaiguri (3) Rahul Das-(M/19yrs) S/O- Sumon Das of Beldangi Shiv mandir, PS- Matigara, Dist. Darjeeling arrested on 11.12.24 u/s- 35(1) of BNSS along with following seized articles viz: -

1. One iron-made crowbar measuring about 22 inches (approx) from the possession of accused Pradip Das @ Poltu kept in his right hand.
2. One iron made hacksaw with blade measuring about 12 inches (Approx) from the possession of accused Bivash Dutta @ Nontai which was kept in his right hand.
3. One iron made chisel (cheni) with plastic butt measuring about 10 inches (Approx) from the possession of accused Rahul Das which was kept in his right hand.

I, SI Koushik Raha S/O- Jitendra Raha of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons and six/seven others to the effect that, on 11.12.24 at about 00.45 hrs received a source's information that 10/11 persons have assembled at abundant Custom quarter, Deshbandhu Para under Siliguri PS for preparing to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No.535 Dated 11.12.24 Subsequently after sharing the information with I/C PS and as per his direction, at 00.55 hrs myself along with SI Uday Chakraborty, ASI Debasish Das, ASI Rabin Lama, C/160 Soumen Sarkar along with kits left for the place to work out the information. This refers to Siliguri PS GDE No-536 dated 11.12.24.

We reached PO at 01.00 hrs on 11.12.24 and waiting there, subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offense and were about to move from that Place. Sensing the police had cordoned off, they tried to flee away but on hot chase, we managed to apprehend the above-noted 03 (Three) accused persons along with seized articles as mentioned above. However, the other 6/7 persons managed to flee away from the spot taking advantage of the darkness. On interrogation, the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area.

I thereafter, seized the above-noted weapons under the proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made on 11.12.24 in between 01.05 hrs to 01.20 hrs) Thereafter, I arrested the above-noted accused persons u/s 35 (1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied a copy of arrest memo to them. The process of search & seizure has been audio & video graphed at the PO.

I accordingly, brought the arrested accused persons along with seized articles to Siliguri Police Station for further investigation. During interrogation, they stated that they were gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above-noted accused persons viz. (1) Pradip Das @ Poltu-(M/33 yrs) S/O- Lt. Manik Das of Matangini Colony-II, Tikiapara, W/No- 28, PS- Siliguri, Dist. Darjeeling (2) Bivash Dutta @ Nontai-(M/35yrs) S/O- Lt. Subhas Dutta of Railway Hospital more, Bhuttabari, W/No- 34, PS- NJP, Dist. Jalpaiguri (3) Rahul Das-(M/19yrs) S/O- Sumon Das of Beldangi Shiv mandir, PS- Matigara, Dist. Darjeeling and six/seven others and arrange for its investigation.
