- I, SI Koushik Raha S/O- Jitendra Raha of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons and six/seven others to the effect that, on 11.12.24 at about 00.45 hrs received a source's information that 10/11 persons have assembled at abundant Custom quarter, Deshbandhu Para under Siliguri PS for preparing to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No.535 Dated 11.12.24 Subsequently after sharing the information with I/C PS and as per his direction, at 00.55 hrs myself along the information with I/C PS and as per his direction, at 00.55 hrs myself along with SI Uday Chakraborty, ASI Debasish Das, ASI Rabin Lama, C/160 Soumen Sarkar along with kits left for the place to work out the information.
