Subject - Written Complaint

Sir,
I, Manoj Kumar Sharma, S/O Suresh Sharma, resident of Gandhi Nagar, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to hereby lodge this written complaint to the effect that I am the lawful owner of the land being measured 6 kathas 9 chattaks being situated at Siliguri municipal Corporation Ward No. 43, Pargana- Baikunthapur, P.S. Bhaktinagar, Mouza- Dabgram, Khatian No. 66, plot no. 36/78, 37/79 and it is pertinent to mention that I am in possession in the aforesaid land since last 25 years. That few hooligans namely **1.** Devendra Ray, Resident of Gandhi Nagar, **2.** Santosh Chhetri, Resident of Gandhi Nagar, Manpari basti, **3.** Dinesh Prasad Singh @ Master, resident of Prakash Nagar, **4.** Chottan Ghosh, Resident of Gandhi Nagar, **5.** Dinesh Singh @ mamu, Resident of Gandhi nagar, **6.** Kumar, Resident at Gandhinagar Manpari basti, **7.** Rahat, resident of Gandhi Nagar and 4 other hooligans, on 11th of November forcefully entered into my land as

mentioned above with a JCB Excavator with the purpose to excavate my land and they started excavating my land to erect the boundary walls and in furtherance to such unlawful act when I protested such activity they pushed me back and continuing their JCB Excavation.

That whereupon the above named Devendra Ray was possessing swords (Ram Daw) and threatened me with dire consequences and he shall put my life to an end if I did not transfer the possession of the aforesaid land. Whereas the above mentioned persons threatened me that they shall bring their contract killers to kill me and family members. However I had informed such facts and circumstances to the Bhaktinagar police station on 11th of, November, 2024.

That whereas on 15th November 2024 those above named persons brought bamboos into my property to erect boundary walls and when my father refrains them from doing such unlawful activities they pushed my father and started hitting my father with knuckle claws. That it is pertinent to mention that all such unlawful activities are captured in the CCTV Camera which is enclosed herewith.

Whereas the land grabbers threatened me that they shall put an end to my life and my family members if I take any legal recourse.

Considering aforesaid facts and circumstances it's clear that Devendra Ray, Santosh Chhetri, Dinesh Prasad Singh @ master, Chottan Ghosh, Dinesh Singh

@ mamu, Kumar, Rahat and 4 other hooligans has hatched up this criminal conspiracy for their illegal gain/s against me and my family members. So, I request you to investigate the matter and take necessary action against these miscreants in accordance with law.
