Sir,
 I, Mr Prashanta Kumar Mahato, AE&SM Milanpally CCC . do hereby lodge this complaint to the effect that today (11.12.2024 at 14:20 hours regarding theft of electric energy found during routine inspection by myself along with Bhaben Roy, SO (S&LP), Darjeeling Region, Bina Lakra, (S/o- Bernard Lakra), Divisional Engineer (S&LP) , Darjeeling Region and other technical personnel had been to the spot at Jhankar More in the house of Smt. HASINA BANU. After issuing notice to the representative of Smt. HASINA BANU, we check the departmental meter (No.: IPB220825 and ID No: 412093121) found that domestic connection was issued to her. Subsequently, due to non-payment of outstanding dues of Rs 24,974 line was disconnected on 27/11/2024.

On physical inspection, it has been detected that said Smt. HASINA BANU reconnected the line with the WBSEDCL energy meter and enjoying the electricity energy since 27/11/2024 unauthorizedly without any payment resulting in WBSEDCL's financial loss.

She did this intentionally with wrong intention for her wrongful gain. As Smt. HASINA BANU has committed an offence, punishable under section 135(1) (a) and 138(1) (b) of Electricity Act, 2003. So, I, prepared inspection memo and seizure list by seizing the meter in-question along with aluminum wire in presence of witnesses and supplied copies of it to the representatives of the premises owner. The connected load of meter is 2.12 kw & final reading of meter is found 18640 ekwh.

So, it is requested to start a case u/s 135(1)(a) and u/s 138(1)(b) of Electricity Act 2003 (Amendment Act 2007) against Smt. HASINA BANU and arrange for its investigation.
