Dear Sir,

This is to bring to your information regarding an unfortunate theft incident that took place on Sunday, 15 December 2024 between 3.55 to 4.15 pm.

At around 1.00 pm, I, Dina Nath Prasad, residing with my family at Don Bosco Staff Quarters on the Don \$4sco School Road, Opposite to Gate No. 1 of Don Bosco School, Siliguri, had gone out with my family along with my heighbour (Sri. John Tshering Lepcha and his wife) to the Toribari Gumba in Salugara. When we returned back around 5/30 pm, I was shocked to see that my house door was open and the lock was thrown outside. Furthermore, I saw that the almirah door inside my house was left open and the safe was broken, wherein, all our gold, silver and diamond jewellery worth Rs. 4.5 lakh (approx) and Rs. 300/- to 400/- cash was stolen. We immediately informed the local police station, Bhaktinagar P\$, and in response 3 police officers arrived and started the investigation. The CCTV footage shows 2 culprits, rag pickers, broke into the house and committed the robbery. The police officers took the picture of the culprits from the CCTV footage and left.

Sir, we are disturbed and saddened as incidents of thefts are increasing day by day. We therefore, request you to kindly look into the matter with top priority and do the needful in arresting the said culprits and recover our stolen items.
