The details of the incident are as follows:

- 1. On 14th December 2024, My Wife left house at around 3:41 PM After having her lunch to her work place (SWEETY JEWELLERY SILVER & GOLD PVT LTD). I returned to my house by 7.41 pm after my duty off.
- 2. Upon returning, I noticed that my wife's [gold necklace, gold mangal sutra,earrings, silver Pajeb, cash amount, guess orange hand bag, pen drives etc.] was missing from its usual place. The ornament is of significant value, both monetarily and sentimentally.
- 3. I immediately checked the surroundings of my house, but I did not find any sign of forced entry or disturbance in the area. However, I suspect that the theft occurred during my absence, possibly by an unauthorized person who gained access to my home.

As my mother was very ill on that incident taken of theft of my house, I could not FIR on that particular day. But has informed police station Pradhan Nagar and have given dairy.

I kindly request that a thorough investigation be carried out into this matter and the necessary action be taken to recover the stolen ornament and apprehend the culprit(s).
