With due respect I, Sri Mani Roy, Son of Sri Late Mantu Roy, resident of Shivnagar, Under Dabgram I Gram Panchayat,, P.O.Salugara, P.S Bhaktinagar, Dist Jalpaiguri (West Bengal) 734008 inform you that I purchased the vacant land measuring 2 Katha1 chattak L.R.. KHATIAN No 477 and 1502, corresponding to L.R. Plot No.2,90, 91 and 108 (R.S), 210(L.R.) Sheet No. 04, J.L. No. 2, located at Shiv Nagar,pargana Baikunthapur, Mouza Jungle Mohal,, under Dabgram-I Gram Panchayat, JungleeMohal, P.O. Salugara, P.S. Bhaktinagar, District. Jalpaiguri, West Bengal - 734008, from Arati Joyardar, W/O Ram Joyardar, through by virtue of Deed of Transfer of Possession sale dated on 15th July, 2024 from the date of purchase from Smt. After that my brother-in-law i.e. Bablu Baran and my family members taken me Siliguri District Hospital formy Treatments. That aforesaid person is local hooligans, land grabbers and very influencer persons. That it was clear that their intentions were to kill me so that they could grab our land for their ulterior motive. Whereas the land grabbers threatened me that theyshall put an end to my life and my family members if Itake any legal actions.

That Lakhan Chandra Barnan and his persons are very desperate persons and they can take the law in theirs hands. So I therefore request before you to kindly look into the matter and do the needful under the provision of law and protect me from the aforesaid persons.

I shall be highly obliged for this act of kindness.
