In producing herewith following four accused persons namely (i) Suman Roy (M/29), s/o- Late Bablu Ch. Roy, r/o- Gossainpur near Post-Office, PS- Bagdogra, Dist- Darjeeling, (ii) Dheeraj Girani (M/26), s/o- Raju Girani, r/o- Bhujipani, PS- Bagdogra, Dist- Darjeeling, (iii) Jiban Das (M/25 yrs), s/o- Narayan Das, r/o- Gossainpur, Notun Para, PS- Bagdogra, Dist- Darjeeling & (iv) Swapan Mandal (M/22), s/o- Late Goutam Mandal, r/o- Bhujipani Chhat, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One iron made hammer having total length approx 16 inches seized from the possession of accused Suman Roy (front right side waist) & marked as Exhibit-A.
- (ii) One iron made shabal having total length approx 24 inches seized from the possession of accused Dheeraj Girani (backside of waist) & marked as Exhibit-B.
- (iii) One cotton made rope of white colour having total length approx 18 feet seized from the possession of accused Jiban Das (concealed inside backpack) & marked as Exhibit-C.
- (iv) One black colour backpack styled as "APLL" seized from the possession of accused Jiban Das (concealed inside backpack) & marked as Exhibit-D.
- (v) One black & green torch light wrapped with brown colour cello tape seized from the possession of accused Jiban Das (concealed inside backpack) & marked as Exhibit-E.
- (vi) One iron made daw with plastic made butt having total length approx 20 inches width 02 inches with butt length 05 inches seized from the possession of accused Swapan Mandal (concealed inside wearing apparels) & marked as Exhibit-F.

I, ASI Amit Lama of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested four accused persons and absconding others namely Rabi Oraon of Kamalpur, Arjun Dey of near Hebron School, Kartick Barman of Gossainpur, Sitaram Paswan & Dhiraj Paswan of Lala Busty and unknown others to the effect that today on 21.12.2024 at 00:15 hrs I received reliable source information that some persons are assembled at Gossainpur Notun Para Railway underpass under Bagdogra PS and they have been preparing to commit dacoity. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide Bagdogra PS GDE No. 938 dated 21.12.2024 and formed a raiding team consisting SI Debabrata Kundu, VP/01 Anselam Kujur, VP/02 Prodip Roy, CV/386 Kishor Howladar led by me. Then at 00:25 hrs as per direction of O/C Bagdogra PS, we left for Gossainpur Notun Para Railway underpass under Bagdogra PS vide MCC No. 345/24 dated 21.12.24 to work out the secret source information. This refers to Bagdogra PS GDE No. 939 dated 21.12.2024. On the way we contacted with night mobile van officer SI Utpal Sarkar and informed them to come near Gossainpur Notun Para Railway underpass to accompany us. At around 00:45 hrs we reached near Gossainpur Notun Para Railway underpass under Bagdogra PS where van officer SI Utpal Sarkar, C/778 Kamal Lama, C/851 Chandan Debnath accompanied us and made an ambush there. We parked our Govt. vehicles away from the place. After a while, being shown & indication by source we saw a group of about 10/12 persons there. We started to cordon them from all side. All on a sudden some of them noticed us and tried to flee away from the spot. But after hot chase we managed to apprehend four suspects there in red hand and searched their persons. They were armed with deadly weapons and equipments to commit dacoity, house breaking etc. Accordingly, we interrogated them. On interrogation, they could not give any

satisfactory answer regarding their presence at that place at the odd hours of night. They gave different statement in different times. On prolong interrogation, they revealed their identity as (i) Suman Roy (M/29), s/o- Late Bablu Ch. Roy, r/o- Gossainpur near Post-Office, PS- Bagdogra, Dist- Darjeeling, (ii) Dheeraj Girani (M/26), s/o- Raju Girani, r/o- Bhujipani, PS- Bagdogra, Dist- Darjeeling, (iii) Jiban Das (M/25 yrs), s/o- Narayan Das, r/o- Gossainpur, Notun Para, PS- Bagdogra, Dist- Darjeeling & (iv) Swapan Mandal (M/22), s/o- Late Goutam Mandal, r/o- Bhujipani Chhat, PS- Bagdogra, Dist- Darjeeling (not verified). Finally, they confessed that they were assembled there in order to commit dacoity at Mulajote area under Bagdogra PS. Their other associates namely Rabi Oraon of Kamalpur, Arjun Dey of near Hebron School, Kartick Barman of Gossainpur, Sitaram Paswan & Dhiraj Paswan of Lala Busty and unknown others somehow managed to flee away. They were armed with deadly weapons and equipments to commit dacoity, house breaking etc. We searched for independent witnesses but no independent witness could be found available there at the odd hours of night. Accordingly, I seized those articles (deadly weapons and equipments) viz. one iron made hammer, one iron made shabal, one cotton made rope, one backpack, one torch light & one iron made daw from their joint possession under proper seizure list & label in presence of police witnesses. Finally, I arrested them after telling them the ground of arrest for committing a cognizable offence in presence of Police Officer to prevent them from committing any further offence as well as for proper investigation of the case and issued memo of arrest in this regard. The process of search, seizure, label & arrest was made in between 01:45 hrs & 02:30 hrs on 21.12.2024. The entire process of search, seizure, label & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Under the above fact & circumstances, I request you to initiate a specific case under proper sections of law against the above mentioned four involved arrested accused persons & other absconding accused persons and arrange for its investigation.
