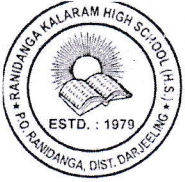


Respected Sir,

I, Shri Prabir Nandi, Headmaster of Ranidanga Kalaram High School (H.S.) inform you that certain Haradhan Mandal, S/O Late Radheshyam Mandal Vill- Kalam Jote (Ghosh Para), P.O- Rangapani, P.S- Phansidewa, Dist- Darjeeling, 734434 has been continuously unauthorisedly entering the premises of Ranidanga Kalaram High School (H.S.) and damaging school property, threatening workers employed by Ranidanga Kalaram High School (in the name of protesting against installation of Mobile Tower). It is to emphasise here that although we have shown them required legal documents and necessary permissions obtained from appropriate authorities, time and again they have forcefully stopped works of Mobile Tower installation. Since stopping of mobile tower installation by them, the work has not progressed till date. Still, on 22.12.2024, Shri Haradhan Mandal with his accomplices unauthorisedly entered the school premise, and ransacked school property (Govt. Property). Repeatedly shri Haradhan Mandal and others are threatening me of further consequences. They falsely accused me of taking monetary advantage from mobile tower Installation Company which has damaged my reputation as the Head of a High School. In this situation I am facing tremendous difficulty in running the school and I am afraid that any time any untoward incident may happen in the presence of students and this will affect the students emotionally and may even physically. Moreover I am afraid of my and my staff's personal safety. Shri Haradhan Mandal and his associates' illegal activities are continuously hampering the peaceful atmosphere of the school.

In this regard, I request you to lodge an F.I.R. against Haradhan Mandal and others and take necessary action and oblige me thus.
