

Due to this accident, I suffered fracture left clavicle and feature left scapula, and currently undergoing treatment in the hospital.

In addition, this accident has caused emotional and financial loss to our family. The long-term medical expenses of me and the financial strain that our family has to bear to provide me with care have been extremely disrupted. Our family has been deeply affected by this accident, and the recovery process will take a long time.


I request you to conduct a proper investigation into this matter, file an FIR against the driver of the vehicle for negligence and reckless driving and take necessary legal action.
