Sub: Written complaint against one Amitabha Basu (Ph.6294331816) S/O Sri Debrata Basu resident of South Deshbandhu para, P.O Siliguri Town, P.S Siliguri, Dist. Darjeeling, and his associates/goons.

Respected Sir,

I Sri. Jagannath Roy S/O Lt. Nalini Roy resident of Sarat Chandra Pally, Haiderpara, Ward No.40, Dist. Jalpaiguri, Pin-734006, would like to draw your attention to the following effect that on 16th December, at about 7.30 P.M while I was going from my above-mentioned address towards Hakimpara to bring my son from his tuition classes but opposite to Central Bank, Haiderpara Branch, around 5-7 people gherao me and stopped my bike, and asked me to give registry infavour of the aforesaid Amitabha Basu, then I told them that in the year of 2013, I have already given registry, infavour of aforesaid Amitabh Basu, so question of registry does not arise again.

Then the aforesaid persons started beating me using Fist and blow on my body for which I sustained severe body ache, in the meantime, some passersby stopped and raised protest the assailant for which the aforesaid persons fled from there by saying that if I will not make registration then the aforesaid person will kidnap me for the same, after that I rang my Wife through phone i.e. Smt. Gopa Roy and my Wife immediately came and took me home and after taking some rest, I became sick due to abovementioned assault, then my wife took me in Siliguri District Hospital and the photocopy of the Medical Paper is annexed with this complain. After the said incident our whole family is in traumatized condition, basically me and my wife are suffering from, insomnia, anxiety, depression due to fear of them.

Some unintentional delay is appeared to lodge this complain due to illness of my wife.

In view of above you are requested to take proper legal action asper law and book the above culprits.
