I, **Dolma Bhutia** W/o Dewa Tseten Bhutia, resident of presently residing at
Salbari, P.O:- Panchannai, P.S:- Pradhan Nagar, in the District of Darjeeling
would like to lodge a written complaint against the above named miscreants
to the effects as follows:-

1. Sir, the above-named miscreants are **land grabbers & Land Mafias** and
are **members of syndicate involved in committing organised crimes**
by illegally capturing the lands of innocent person on the basis of
false and fabricated documents and with the intention to take the illegal
and forceful possession of our landed property since last few days said
miscreants are continuously disturbing my peaceful possession of our
landed property measuring 4 kathas recorded in L.R. Khatian No.3091
forming part of L.R Plot No.627, Mouza:- Panchkulguri, J.L No.59, Police
Station:- Matigara, District:- Darjeeling wherein I am in the process of
constructing our house and recently when said miscreants have
crossed all the heights and limits on **19.12.2024**, I have approached
your P.S. and lodged first written complaint on said date against the
above-named miscreants No. 1 & 2 and their associates wherein I
have informed your good police station that the said miscreants
illegally entered our land and outraged my modesty and assaulted me
and threatened me that if ever I did any construction activity over our
land said miscreants will kill me and once again on **21.12.2024** the
above named miscreants along with several others goons in order to
achieve their objectives of capturing my land have set fire in the
temporary residential structure over our land with the intention to kill

our labors working at our site and further assaulted me and threatened me that if ever I did any construction activity over our land said miscreants will kill me and once again I lodged another complaint which was registered as Matigara P.S Case No.747 of 2024.

2. That despite of specific criminal case against the above named miscreants today at around 5.10 P.M. while I was at our landed property with few numbers of labours and getting the construction work done, I was shocked that the above-named miscreants namely **Md. Salman, Md. Nasirul @ Baisakhu, Sourav Kumar** along with few men and persons illegally entered into our land carrying deadly weapons (i.e. Knife, lathis, sword etc) and started abusing us with bad and filthy languages which cannot be utter in a civilised society and firstly made my labors run away by assaulting them with said deadly weapons and further damaged all my construction materials. However, when I protested the above-named miscreant namely **Md. Salman** informed me that they are very powerful and influential criminals and ever the Judicial officers get scared listening their name as they are very well known criminals who do not even hesitate to kill persons and further **finding me alone and helpless** said **Md. Salman** suddenly gave a severe punch over my face causing my nose bleed which led to disfiguration of my nose, and further said me that he and his associates have got bail from the Ld. Court Siliguri on 24.12.2024 and they are not scared of any legal system or police authorities and further gave a severe blow over my chest upon which I fell down and taking advantage of the situation he gave me tight kicks on private parts of my body and further he tore my clothes and made me naked and captured my naked pictures in his mobile phone and threatened me that if I made any complaint or further attempted to construct a house over our land he will circulate my naked pictures over social media, over my protest said **Md. Salman** strangled my neck with intention to kill me, however listening my cry when local people intervened said miscreants run away with the threatening that earlier they have burned our property next time they will burn my face by throwing acid over my face and further I noticed that said miscreants took away my gold chain of 12 grms and purse containing around Rs.15000/- and valuable documents.

3. That after the said incident my well wishers took me to the Hospital for my immediate medical treatment.
4. That it has come to my knowledge the above-named miscreants are habitual offenders and several numbers of criminal cases are registered in the name of above-named miscreants.
5. That presently in the hours of terror we are under great threat of losing our property and said miscreants in order to achieve their malafide intention may go to any extent of violence and killings. Be it mentioned here that there has been continuous attempts from the end of said miscreants and their men and agents to illegally grab our landed property which we purchased for valuable consideration.
6. That considering the above facts and circumstances, I humbly request your good self for taking immediate and strong action against the above said miscreants under appropriate criminal laws for the ends of Justices.
