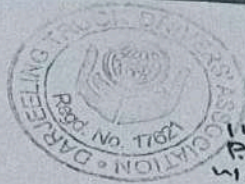

Name of the persons are as follows (1) Basi Roy, father name locally known as Boulder (2) Lipi Barman (female) and friends

During the assault, ~~my~~ ^{his} cash money which was around 35000/- (Thirty five thousand) is missing, hence the conditions of driver is not good and he is taken to hospital for further treatment.

We, therefore on behalf of Darjeeling Truck Drivers Association would request you to kindly take the necessary actions to the culprits, so, we feel secure in doing our job. Looking forward for quick action as per the law.
