Subject: Written Complaint

Dear Sir,

With due respect, I the undersigned would like to inform you that on and from the date of solemnization of my marriage, since 2015, I am residing with my husband, Sri Manoj Yadav, son of Biswakarma Yadav at Harekrishna Pally, P.O. & P.S. Bagdogra, District - Darjeeling, West Bengal and one Muneshwar Mahato, son of not known, his son Shyam Mahato and his daughters Punam Mahato and Gurdiya Mahato, who were our neighbors and also the local residents of the said address were well known to me and my husband but always quarreled with me and my husband on trivial issues by abusing filthy languages upon us and kept me and my husband under continuous threat but however after sometime, both the sisters left the place and went to reside in a tenanted premises at Baghajatin Colony, Ward No. 45 of S.M.C, P.O. & P.S. Pradhan Nagar, District - Darjeeling and we started to live our lives peacefully.

I would like to further inform you that my husband is deployed under Indian Armed Forces and presently posted as "Trademill Mate' with unit 5 Field Ordinance Depot, Bengdubi posted at Ministry of Defence, Area Account Office, situated at Sevoke Road, P.O. - Sevoke Road, P.S. Siliguri and on 25.12.2024, due to the declaration of holiday on account of Christmas, at around 7:45 p.m. my husband reached out to meet his friend R.K. Gupta at his shop premises situated at Baghajatin Colony, Pradhan Nagar and do some shopping for our home and in the meantime said Punam Mahato and her sister Gurdiya Mahato alongwith one Siddharth, son of not known also arrived at the said shop and finding my husband therein they again started to tease him and abused filthy languages upon my husband but when my husband peacefully protested against their said act, Punam Mahato slapped upon his face publicly and all of them started to hit my husband with fists and blows and also threatened him that they are women and possess power to implicate him in frivolous and false criminal cases and left the said place and said activities have been covered under CCTV installed at the shop premises of said R.K. Gupta.

I would like to further inform you that thereafter my husband after returning to home in injured condition narrated me everything and next day on 26.12.2024, at around 12 noon, I alongwith my husband went near the councilor office of Ward No. 45 of S.M.C. to enquire the said sisters and their friend Siddharth for knowing the reason behind said physical assault on my husband but upon reaching, we found that both the sisters, Punam Mahato and her

sister Gurdiya Mahato alongwith their father Muneshwar Mahato and said boy Siddharth came running towards me and my husband without affording us any opportunity to resist, they started to hit me and my husband with kicks and blows and their father Muneshwar Mahato physically assaulted me by holding my hairs and kicking me to the ground and the said boy Siddharth also squeezed my throat and shamelessly hit me over my private parts and thereafter before leaving, said Muneshwar Mahato threatened us of dire consequences that he will get me and my husband murdered by his son Shyam Mahato who is having strong influential political connections and they will not hesitate in taking our life. Somehow, me and my husband were taken to Siliguri District Hospital for our treatment.

Due to the threat and physical assault, me, my husband and my two minor sons are living our lives in extreme fear and hence I am submitting this complaint.

Under the above circumstances I would like to request you to investigate the matter and take necessary suitable action under relevant provisions of law.
