Sir,

In producing herewith the following accused person namely Babusona Sarkar (30 yrs) S/O Parimal Sarkar of Pokajjote, near Kali Mandir, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following articles under seizure viz :- (i) One Truck (TATA-S1312) having Registration number WB/78/0309 loaded with with illegal River bed materials under proper seizure list. I, ASI Amar Raj Subba of Pradhan Nagar P.S, SPC do hereby lodge this Complaint against the the above noted arrested accused persons namely Babusona Sarkar (30 yrs) S/O Parimal Sarkar of Pokajjote, near Kali Mandir, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and the owner of the said seized vehicle to the effect that on 06.01.25 at 21.00 hrs onwards I was engaged to perform RT Mobile van duty vide GDE No 313 dated 06.01.24 and MCC No 44/25 dated 06.01.25. In course of my RT Mobile van duty at 22.15 hrs I received a specific source information that one truck bearing Reg. No. WB/78/0309 loaded with illegal River bed materials was coming towards Pabitra Nagar side from Mahananda river Bed, under PS- Pradhan Nagar, Dist.- Darjeeling without any valid documents. Accordingly, I informed the fact to you over mobile phone and as per your kind order and direction myself along with force had been to Pabitra Nagar under PS- Pradhan Nagar, Dist.- Darjeeling. At around 22.35 hrs the source informed me that the said vehicle will reach Pabitra Nagar within a short period of time. At around 22.45 hrs we detained the said truck displaying number plate WB/78/0309 loaded with illegal River bed materials at Pabitra Nagar under PS- Pradhan Nagar, Dist.- Darjeeling and also found that the driver was inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above. On demand he failed to produce any documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he with the help of his owner mines such river bed materials from Mahanda River by illegal means with a view to sell the same to their design customers for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WB/78/0309 leaded with illegally mining river bed materials under proper seizure list and subsequently arrested him after maintaining all formalities of arrest and brought to Pradhan Nagar PS for further investigation. The search and seizure was made in between 22.55 to 23.25 hrs. At the spot under the coverage of videography.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused persons namely Babusona Sarkar (30 yrs) S/O Parimal Sarkar of Pokajjote, near Kali Mandir, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling and the owner of the said seized vehicle and arrange for its investigation.
