In producing herewith five (05) accused persons namely (i) Anil Sharma (22 yrs) S/O Kumar Sharma of 5 th Mile, Gangtok, PS- Ranipul, Dist.- East Sikkim, Sikkim (ii) Chris Limbu (25 yrs) S/O Bipin Limbu of Samdur, Ranipul, PS- Ranipul, Dist.- East Sikkim, Sikkim (iii) Ujjwal Chhetri (34 yrs) S/O Uday Chhetri of Pokhrebong Bazar, PS- Sukhia Pokhri, Dist.-Darjeeling (iv) Md Raja (22 yrs) Aftab Alam of Koila Depot, Ward No -07, PS- Siliguri, Dist. Darjeeling and (v) Md Budha (24 yrs) S/O Haffijuddin of Ratanlal Busty, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz; (i) One iron made sharp cutting weapon locally called as "Khukuri" measuring 18 inches in length including wooden handle (ii) one iron made sharp cutting weapon locally called as "Hasua" measuring approx 56 cm in length (iii) one iron made hammer measuring approx in length including its wooden handle (iv) one iron made bolt cutter measuring approx length 14 inches in length (v) one iron rod measuring approx 84 cm in length (v) one black and red colour torch light and (vii) one white colour nylon bag. I, ASI Sajal Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted five (05) arrested accused persons and others 05/06 unknown miscreants who involve in this crime to the effect that on 10.01.25 at 00:40 hrs I received a specific source information that about 10/11 miscreants equipped deadly weapons assembled at Rajib Nagar near Darjeeling More under PS- Pradhan Nagar, Dist.- Darjeeling and are taking preparation for committing Dacoity at Rajib Nagar and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No 520 dated 10.01.25 and as per your kind order and direction myself accompany with SI Rajiv Subba, ASI Prabal Sarkar, ASI Biplab Kr Das all of Pradhan Nagar PS, SPC left for Rajiv Nagar under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed RT van officer SI Biswajit Biswas of Pradhan Nagar PS and requested him to come to Rajib Nagar to accompany with us. At around 00:50 hrs we arrived at Rajib Nagar and after a while R.T van officer SI Biswajit Biswas arrived there and accompany with us. I shared the information with them and briefed them properly. Then, I contacted with my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I requested two independent witnesses namely (i) Bimal Roy S/O Biplab Roy of Gas Godwn, Ujjanu, PS- Matigara, Dist.- Darjeeling and (ii) Jayanta Roy S/O Paresh Roy of Ambika Nagar, PS- NJP, Dist.- Jalpaiguri and I shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards place and cordoned the place with due care and cautioned and from a considerable distance we noticed that some persons were assembled in a dark place at Rajib Nagar and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted 05 (five) accused persons while 05/06 others unknown miscreants managed to fled away from the spot taking the advantage of darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which was they kept conceal inside a nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 05/06 of their associates assembled there and were making preparation for committing Dacoity at Rajib Nagar and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 01.15 hrs to 01.55 hrs on 10.01.25 at the spot in presence of independent witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of their arrest. The whole process of search and seizure were made under the coverage of video graphy executed by Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabindapally, Ward No-22, PS-Siliguri, Dist.- Darjeeling as per norms of BNSS and brought all the five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at Rajib Nagar and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Anil Sharma (22 yrs) S/O Kumar Sharma of 5 th Mile, Gangtok, PS-Ranipul, Dist.- East Sikkim, Sikkim (ii) Chris Limbu (25 yrs) S/O Bipin Limbu of Samdur, Ranipul, PS-Ranipul, Dist.- East Sikkim, Sikkim (iii) Ujjwal chhetri (34 yrs) S/O Uday Chhetri of Pokhrebong Bazar, PS- Sukhia Pokhri, Dist.- Darjeeling (iv) Md Raja (22 yrs) Aftab Alam of Koila Depot, Ward No -07, PS- Siliguri, Dist. Darjeeling and (v) Md Budha (24 yrs) S/O Haffijuddin of Ratanlal Busty, Mallaguri, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and others 05/06 unknown miscreants and arrange for its investigation.
