Ltd., a company registered under the Companies Act 2013, having its registered office at 6th floor, Sky Star Building, Sevoke Road, Siliguri, Pin 734001, file this present complaint on behalf of the Company inform your good office the following:

That Summit Hotels & Resorts Pvt. Ltd. being in hospitality business, desired to expand its business in the state of Himachal Pradesh and for such expansion it approached Bahra Creative Infrastructure Pvt. Ltd., represented through its Chairman Mr. Gurvinder Singh Bahra, to grant lease of their property namely Thistle Villa and Luxury Resorts, Mashobra, situated in Mashobra Town under the District of Shimla, owned under the name of Bahra Creative Infrastructure Pvt. Ltd. (BCIPL).

That Mr. Gurvinder Singh Bahra (Chairman of BCIPL) leased out his said property (Thistle Villa and Luxury Resorts Mashobra) to and in favour of our Company by virtue of a Deed of Lease dated 21st April 2018 for a period of 9 years. After taking possession of the said property thereafter, we refurbished and furnished the entire resort and renamed it as Summit Thistle Vila and Luxury Resorts Mashobra.

Thus, we being constrained in such a situation had no other option but to terminate the Lease Deed with effect from 2 June 2020 which was mutually decided and agreed between Mr. Gurvinder Singh Bahra (Chairman of BCIPL) and our Company, and the said termination was conducted vide a Settlement agreement dated 08.09.2020 which detailed the refund of the interest free refundable security deposit and unadjusted advance for the sum of resundable security deposit and unadjusted advance for the sum of Rs.1,62,84,954.00 (Rupees One Crore Sixty Two Lakh Eighty Four Thousand Nine Hundred And Fifty Four Only) by Mr. Gurvinder Singh Bahra via Cheques/Bank.

That Mr. Gurvinder Singh Bahra paid Rs.1, 37, 84, 954. 00 (Rupees One Crore Thirty Seven Lakh Nine Hundred and Fifty Four) only to our Company and the last payment was on 12.11.2021. From the very inception Mr. Gurvinder Singh Bahra acted against the settlement agreement's terms and conditions and defaulted in making the payment, but transferred the said outstanding amount in various installments varying from the terms. Our company in good faith adjusted the defaulted payments and accepted further payments in lieu of those and never took any legal steps.

On 10/01/2022, one of the cheques issued by Mr. Gurvinder Singh Bahra was dishonoured and returned by our bank with the endorsement "Insufficient

funds. Our company representatives informed Mr. Gurvinder Singh Bahra about the same, and he accepted that due to some emergency in one of his business he had to divert huge fund from all other businesses including the one with us, and thus the insufficiency of the funds. He further requested to not present the other cheques which he has given for payment of the outstanding amount, and further assured that he would make the payment at once but will take some time, no later than within three months.

That despite Gurvinder Singh Bahra committed a criminal offence, our company based on his assurances did not take any legal step against Mr. Gurvinder Singh Bahra.

Mr. Gurvinder Singh Bahra is indebted to repay the remaining amount of Rs. 25, 00, 000.00 (Rupees Twenty Five Lacs) only. But now, after elapse of certain period, Mr. Gurvinder Singh Bahra intentionally ignored our calls, e-mails and did not even receive any notice sent by us at the registered address making his intentions clear to defraud us.

Finding no alternative our company served legal notice through our Advocate at both the address of Mr. Gurvinder Singh Bahra in which he holds directorship and have remitted payment to our company i.e. Rayat-Bahra University, Chandigarh-Ropar NH 205, Greater Mohali, Punjab, Pin – 140103 and at his registered address Bahra Creative Infrastructure Pvt. Ltd., SCO 126-127, 4th Floor, Sector 34A, Chandigarh, Pin – 160022.

That inspite of service of one the notice at Rayat - Bahra University, any payment has not been made nor has he replied which makes his intention very clear to cheat us causing breach of trust and his said act clearly reflects his malafide intention to refrain himself of paying our company's money. His act and conduct is completely illegal and in contravention of the law of land.
