Siliguri, District Darjeeling would like to state that I have purchased one flat from Ravikant Agarwal, S/O - U. Kausatnal Agarwal, R/o - Santoshi Nagar, Near Shayam Mandir, ward No. -5, P.O. & P.S. Siliguri, District-Darjeeling (who is a promoter) and I live in the aforesaid address for past 4 years and after seeing the building plan and other documents of the said said Ravikant Agarwal is building illegal construction on the said apartment as well as constructing a new building illegally and thereafter I have made one complaint to the Siliguri municipal Corporation through mail and thereafter in response from the said authority one inspection notice was received from the Commission of S.M.C. dated 06.01.2025 directing to remain present at the aforesaid premises along with the building plan and other relevant documents. It is important to mention here that after receiving the said notice the above name person Ravikant Agarwal became angry and furious and thereafter started to threatened me with dire consequences and thereafter on 08/01/2025 said person hired local goons/mafias to assault me as well to

I received a phone call from a unknown number 7908820829 and thereafter threatened me over phone and also they came in front of my house in red color car namely 1) Bijoy Sahni, S/o - Lt. Lal Bahar Sahni, R/o - Ganganagar near Sunil Shop factory, 2) Bikash Thakur Channa, S/o - Bhogteshwar Thakur, R/o - Ganganagar, P.O. & P.S. - Siliguri, 3) Pintu Sharma, S/o - Not known, R/o - Santoshi nagar, Nachlinore, Siliguri, 4) Birju Gupta, S/o - Mahesh Gupta, R/o - Bander Khatol, Ganganagar, Road No. - 2, Siliguri and other associates along with sharp weapons as well as with guns and started to me and my family members in filthy language and they were all aggressive to kill me and when I oppose them they started to assault me with various weapons and also stated that if they see me anywhere they will kill me and my family members and if I don't leave from the said premises they will kill me as soon as possible.

It is pertinent to mention here that me and my family members are spending our days with fear and the above named persons are very dangerous people and they are the habitual offenders as well as mafias and many cases are pending against them.

Therefore finding no other alternative way I have come before you to lodge this complaint against the above named persons and kindly look into this matter and take appropriate legal actions on those persons as soon as possible.
