Sir,

1. **SRI RAVI KANT AGARWAL** S/o Late Rawatmai Agarwal, being the proprietor of **M/S SITA ENTERPRISE**, a Proprietorship Firm having its office at Santoshi Nagar, Near Shyam Mandir, Post Office & Police Station:- Siliguri in the district of Darjeeling would like to write you as follows:-

1. That, my above named firm is engaged in the business of construction and development of multistoried buildings and towers, one among them being a multi-storied building known as **Anjani Apartment (Block-F)**, located at Ganga Nagar, Ward No. 5, Post Office & Police Station Siliguri, District of Darjeeling, Pin: 734005.
2. That firm has conveyed 23 number of flats in the aforementioned building to various individuals by executing separate registered deeds of conveyance. At the time of sale, it was expressly communicated and agreed by each purchaser that in future if required for further development, the firm may remove the boundary wall on the norther side and each purchaser acknowledged and agreed to this condition, as evidenced by the "No Objection Certificate" (NOC) included in their respective purchase deeds in Point No. 10 & 11 of NOC.
3. That as per the said NOC attached to the said deed, Firm has recently in the month of October, 2024 have removed the boundary wall on the norther side and since thereafter the above-named miscreant has been threatening me with dire consequences and has even threatened me to implicate me in false criminal cases and be it mentioned here that complaint has been made by him before the Siliguri Municipal Corporation and investigation is going on.
4. That Today on 09.01.2025, four number of unknown persons claiming to be the **goons and agent** of above-named miscreants namely **DURGA NAND MISHRA** have come to my office and have assaulted me with fists and blows

who were carrying a "GUN" with them and pointed the same at me and demanded a sum of Rs. 5,00,000/- instantly and have threatened me that if removed wall is not restored they would not hesitate to kill me but somehow on my strong resistance they flee away.

5. That in the hours of terror I humbly request you to take appropriate legal actions against the above-named miscreant and his goons.




