Sir,

In producing here with the one arrested Lady accused Rafika Beba 45 yrs w/o Late Kabul Hossain R/O Tikiapara, Matangini (II), ward no 28 PS- Siliguri Dist- Darjeeling along with Fourteen (14) PET bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 160 X 14 = Rs 2240/-)

I ASI Rabin Lama S/O Birendra kumar Lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested lady accused Rafika Beba 45 yrs w/o Late Kabul Hossain R/O Tikiapara, Matangini (II), ward no 28 PS- Siliguri Dist- Darjeeling to the effect that on 10/01/2025 at about 08.05 hrs I received a source information that one lady named Rafika Beba of Tikiapara, Matangini (II) is busy to selling huge quantity of liquor illegally in Tikiapara Vegetable Bazar to her design customers from since long for her wrongful gain. The fact diarized in GD (vide Siliguri PS GDE no 751 Dated- 10/01/2025) and informed to I/C Siliguri Police station and as per his kind instruction, I along with ASI Debasish Das, LHG 493 Parul Chakraborty accompany with K21 van officer ASI Mahasagar Barman, constable no - 384 Biswanath Barman, Constable no - 1466 Parimal Das left for Tikiapara, Vegetable Bazar to verify and veracity of the information (vide Siliguri PS GDE no 752 dated 10/01/2025). At about 08.45 hrs myself along with accompanied force reached at Tikiapara, Vegetable Bazar, ward no 28, under Siliguri PS and on being shown and identified by the source I along with my accompanied officer & force managed to apprehend the said Lady, on interrogation she disclosed her identity as noted above. On searched I recovered Fourteen (14) PET bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, each bottle value of Rs- 160 X 14= 2240/- (Two Thousand Two Hundred and Forty Rupees) was on her possession. On further interrogation she admitted that she used to sale in the early morning to her design customers since long for her wrongful gain. On demand she failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz; Fourteen (14) PET bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 160 X 14 = Rs- 2240/-) from the possession of Rafika Beba 45 yrs w/o Late Kabul Hossain R/O Tikiapara, Matangini (II), ward no 28 PS- Siliguri Dist- Darjeeling in which one (1) sealed PET bottles of Himalayan Gold 60 up country spirit contain 600 ml has taken out from mother packet (marked as exhibit-A) as sample marked as A- 1 after prepared seizure list (seizure and labeled was made between 08.59 hrs to 09.15) in presence of witnesses duly sign by the witnesses as well as acknowledge by the lady accused the process of search and seizure was recorded audio-video graphed. As she violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 35 of BNSS and appraise her ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Lady accused Rafika Beba 45 yrs w/o Late Kabul Hossain R/O Tikiapara, Matangini (II), ward no 28 PS- Siliguri Dist- Darjeeling under proper section of law.
