Respected Sir,

I, Smt. Bipashna Chhetri, Wife of Sri Sujan Khaling, presently residing at Old Railway Siding, Upper Hill Cart Road, P.O. - Rangbul, P.S. - Jorebunglow, Dist. - Darjeeling, would like to lodge this complaint that my husband viz. Sri Sujan Khaling has purchased one land measuring 3 Katha, recorded in L.R. Khatian No.- 748, under R.S. Plot No.- 165 corresponding L.R. Plot No. - 627, situated at Mouza - Panchkelguri, within Police Station - Matigara, Dist. - Darjeeling, by virtue of a registered Deed of Conveyance being Deed No. - I- 3368 for the year 2021.

Sir, after purchasing the aforesaid land, my husband has mutated his name with the office of B.L.&L.R.O., Matigara, vide new revised L.R. Khatian No. - 2992 and thereafter, my husband has converted his aforesaid land from the category of "Rupni" to "Bastu".

Sir, since the date of above purchase, my husband has been using, enjoying, occupying and possessing the aforesaid land, by constructing one dwelling house thereon, peacefully and uninterruptedly, without any sorts of objections and obstructions from anybody else whomsoever.

Sir, in the year 2022, when my husband has constructed the dwelling house, then Md. Salman, Pappu Roy and Md. Nasirul @ Baisaku had illegally demanded a sum of Rs. 5,00,000/- (Rupees Five Lakhs) only with my husband as gunda tax, but my husband could not able to pay the same due to our financial crunches, even after their tremendous pressure.

Sir, suddenly on 01.01.2025, in the morning, some land mafias viz. 1. Md. Salman, Son of Md. Pania, 2. Pappu Roy, Son of Suresh Roy, 3. Md. Nasirul @ Baisaku, Son of Mafizuddin, 4. Monika Begum, wife of Md. Nasirul @ Baisaku, 5. Surjahan Khatun, Daughter of Md. Nasirul @ Baisaku, 6. Yasmin Khatun, daughter of Md. Salman, 7. Sohana Parvin, daughter of Md. Salman and 8. Jahanara Begum, wife of Md. Salman, have suddenly come and forcibly entered into our aforesaid land and thereafter, in collusion and in connivance with each other, all of the aforesaid

persons have illegally broken our dwelling house and the concrete boundary wall, as we could not able to meet with their illegal demands of gunda tax of Rs. 5,00,000/- (Rupees Five Lakhs) only.


Sir, our dwelling house and boundary was completely demolished by the aforesaid persons and they have openly threatened that if my husband will not pay them Rs. 5,00,000/- (Rupees Five Lakhs) only in cash to them, then they will forcibly capture our aforesaid land and they also illegally sell the same to the third parties by using their muscle power.

Sir, the aforesaid miscreants are well known land mafias in the area and numerous criminal activities have already been done by them, as they used to manufacture forged documents and through which they used to forcibly capture the land of innocent persons and always they used to show their muscle power and several criminal cases are also pending against them.

I, therefore, am humbly requesting you to take drastic legal actions against the aforesaid persons viz **1. Md. Salman, 2. Pappu Roy, 3. Md. Nasirul @ Baisaku, 4. Monika Begum, 5. Surjahan Khatun, 6. Yasmin Khatun, 7. Sohana Parvin and 8. Jahanara Begum**, in accordance with law and your good office and urgent co-operation is very much expected in this regard.
