Then "AMALTHEA" Unisex SPA at the basement of City Centre and, seeing the Police party raid, search and seizure if any. Subsequently, we proceeded into the shop styled as Tindharia, Chunabhathi, PS- Kurseong, Dist- Darjeeling to remain present during the time of Chowrasta, PS- Sadar, Dist- Darjeeling, (ii) Sreyas Pradhan, D/O Lt. Nitin Pradhan of independent witnesses namely (i) Muskan Chhetri, D/O Amit Chhetri of Darjeeling near verify the veracity of information. On interrogation, they disclosed their identity as noted above and both the lady admitted that they have been indulged in the business of prostitution with well acquainted with the owner of said massage parlour for their livelihood and earn money by engaging themselves in illegal prostitution by using said massage parlour as Brothel. On being asked about the owner of the SPA both the female accused disclosed the name of the owner as Cahhma Subba but they also added that they are unaware about the exact location of her residence . They further revealed that they were carrying the business of prostitution under the camouflage of Body massage parlour for their illegal gain and also admitted that they meet up the urged of customers by demanding extra money and provide them sexual favour. Accordingly, we searched the "AMALTHEA" Unisex Massage Parlour in presence of independent witnesses and found (i) One exercise book Saathi noted " Amalthee" 64 on first page. On 17 page there are three entry date 10/01/25 last entry (3)BM-700-Niki-DS..02:13-1400, (ii) One phonePe QR code payment machine" Nexgo". (iii) Two numbers of used condoms "love me" pink. Accordingly, I seized the same under proper seizure list in presence of witnesses. Subsequently, I searched for the owner of "AMALTHEA" Unisex Massage parlour but, no one could be found. Then, I arrested accused namely i) Suman Ghosh( 34 yrs) S/O Subal Ghosh of Newtown Para, Ward No-19 PS Kotwali, Dist Jalpaiguri, (ii) Anju Chhetri (37), w/o Late Sanjib Chettri D/O Late- Kumar Chettri of Bhutia Busty, P.S- Sadar, Dist- Darjeeling (iii) Nikita Chettri (24 yrs) D/o Uday Chettri village Bhutia Busty, PS Sadar Dist Darjeeling u/s 35 BNSS observing all formalities. The whole process of search and seizure was made in between 14:30 hrs to 15:10 hrs under proper videography as per the BNSS norms. The female accused were arrested maintaining all dignity and decency with the help Lady Police personnel noted above. Subsequently, I brought them to Matigara PS.
