With due respect and humble submission, I am Marisha Pradhan wife Suman Leptha, a resident of Digi Apartment Employment Exchange Road, near Employment Exchange, Ward 22, Hakimpura, Siliguri West Bengal 734001. I am writing to formally report an accident that occurred on 1st January 2025 at approximately 7 AM at Hakimpura locality.

Details of the incident:

While we were travelling on IP (Baran) road no. 23, near a pharmacy in Hakimpura, we were involved in a road accident caused by a vehicle (unknown four wheeler car) driving recklessly. We were in a two wheeler (scooter) and heading towards home when a white coloured car (did not catch the license plate number) crashed into me. The collision occurred due to the other driver's negligence. The driver was speeding, and it appeared they were under the influence of alcohol.

Injuries and Damage:

As a result of the crash, I and my husband (Suman Leptha) sustained injuries to our body, head and shoulder and had to seek medical attention at district hospital Siliguri. Additionally, our vehicle suffered significant damage, including a broken headlight, damaged bumper.

Request for Action:

I kindly request your department to register this complaint and investigate the matter. I am providing all available details to aid the investigation. I am also ready to cooperate fully and provide further evidence or witnesses if required.
